**Order:** It is hereby ordered by the General Post Master Council upon motion of the Government of The United States of America to nationalize all Municipal Property of the City of Conroe, state of Texas and named offices and affiliated contractor is justified to resolve human rights violations and expose the violators of these human rights violations to the international community under the classification of terrorists and harboring of terrorist activity; thereby exposing front organizations, corporations and associations of the National Lawyers Guild, a communist organization that uses crimes that qualify as terrorism to promote political change. The respondents are using their power provided to them by the U.S. Military industrial complex, unelected, to steal a motor vehicle from a Government that is not provided the same resources, therefore, in the view of the General Post Master Council, the actions taken by the respondents through their tort-feasors does qualify as terrorism using the violence of theft to force a cover up on the international record and before the international community of the truth that the vehicle identified within the claim is in fact stolen.

**IT IS FURTHER ORDERED**, that the National address of City of Conroe, state of Texas, named offices and affiliated contractor is hereby declared under the survey of The United States of America identified through Natural Area Code (NAC) addresses for the purpose of jurisdiction to adjudicate this dispute and insure that the Law of Nations and the Universal Declaration of Human Rights is upheld.
