Any further liens or claims against said person shall result in a cancellatura of foreign instruments if the City of Conroe cannot produce any physical damages to any of its property. An offense is not classified as physical damages to the property of the City of Conroe.

Violation of this Cancellatura of Foreign Instruments is a violation of international sovereignty as established under the Law of Nations and a violation against the Universal Declaration of Human Rights.
