THE UNIFORM RULE FOR THE JUDICIAL BRANCH OF THE GOVERNMENT OF THE UNITED STATES OF AMERICA ACT OF 2013

Comes now, at least two affirmed American Nationals petitioning the United States, in Congress assembled for a uniform rule for the Judicial Branch of the Government of The United States of America, FURTHERMORE, the repeal of the second General Provision of the Articles of Confederation, as amended, September 5th, 2012,

BE IT ENACTED, by the United States, in Congress assembled, a UNIFORM RULE FOR THE JUDICIAL BRANCH OF THE GOVERNMENT OF THE UNITED STATES OF AMERICA ACT OF 2013 and repeal of the second General Provision of the Articles of Confederation, as amended on September 5th, 2012.

ENACTMENT CLAUSE

The United States, in Congress assembled, having authority to maintain chain of title to the Judicial Power and Authority of The United States of America as a Sovereign Nation, hereby create the International Criminal Court for The United States of America.

1: The International Criminal Court shall have a Judicial Seal, Court rules in the form of Maxims of Law, Criminal Jurisdiction over all matters of a criminal nature, intentional physical injury cases and shall make all decisions based on these three rules:

- 1: Love my neighbor as myself,
- 2: Do unto others as I would have them do unto me, and
- 3: I will seek first the reign of the heavens with all my mind, heart and soul,

2: The International Criminal Court shall have original jurisdiction over all criminal matters with affirmed American Nationals and defense authority of the affirmed American Nationals against other Independent States, foreign States, and Trusts established from time to time. Particularly, constructive trusts created by trustees and executors by felonious conversion of the private record. Furthermore, shall have authority of settlement of the three cestue que acts to settle the Civil War of 1861 through 1865. The Three Judge Panel shall have International jurisdiction and limited Trustee status of the New Yerushalayim World Trust for the purpose as stated above within this section and World settlement authority for those with proof of life through the Notarial Tribunal at the direction of the beneficiary.

FURTHER BE IT ENACTED, by the United States, in Congress assembled, by the authority of the assembly of the majority of the American Nationals assembled that the second General Provision of the Articles of Confederation, as amended on September 5th, 2012 is repealed and replaced with the UNIFORM RULE FOR THE JUDICIAL BRANCH OF THE GOVERNMENT OF THE UNITED STATES OF AMERICA ACT OF 2013,

BE IT RESOLVED, that upon review of the Private Attorney General Association experiment, that to put all legal or law remedy to sustain balance in the hands of one man or one woman becomes a dictatorship in a very short time. It gives that one man or woman the ability to withhold legal or law recourse from the poor or the rich and therefore such a condition must be abolished within The United States of America as that condition is an abomination to the principles of a Confederacy form of Government.

Therefore, it is prudent to form another part of the Judicial Branch for the purpose that serves the rich and the poor equally in all cases. The rich cannot criminally charge the poor in the first instance, nor can the poor charge the rich criminally in the first instance. Unjust enrichment must be avoided at all costs. Any and all accusations will go through a process specifically designed to avoid injury from the Nation as a whole against its people and find the truth before it is buried in a stack of lies and deceit.

FURTHER BE IT ENACTED, by the United States, in Congress assembled that THE UNIFORM RULE FOR THE JUDICIAL BRANCH OF THE GOVERNMENT OF THE UNITED STATES OF AMERICA ACT OF 2013, consisting of a Judicial Branch made up of a Notarial Tribunal for The United States of America, headed by the Secretary of State for The United States of America. The office of peaceful settlement of disputes for The United States of America, headed by the general post office for The United States of America. The International Criminal Court of The United States of America and the Investigators Division for The United States of America, headed by the General Post Master Council for The United States of America. Each part of the Judicial Branch of The United States of America shall have equal suffrage so that one part cannot usurp the powers and authority of the other. All parts of the Judicial Branch of The United States of America, just as any other branch shall be subject to the laws enacted by the assembly of affirmed American Nationals, properly convened.
