JUDGMENT

BE IT JUDGED AND IT IS AGREED, AS THE GENERAL POST MASTER COUNCIL DOES HEREBY UNANIMOUSLY CONCUR ON THE FOLLOWING:

THAT, a change of venue was filed with and accepted by this court of record, and

THAT, there has been no objections to the *Judicial Review--Protest and Order* issued by the Government of The United States of America, for the purpose of seating the Department of Transportation for the Government of The United States of America and establishing human rights in inter-state commerce, made part of the international record on or about December 6, 2015, and

THAT, Marshall Revellyn Rinkenberger is an American National and therefore, a non-citizen, non-resident alien to the United States of America, and

THAT, as a documented American National, Marshall Revellyn Rinkenberger is, by voluntary contract, subject to the General Post Master Council. Any non-recognition of this voluntary contract is a violation of the right to contract. Any person or entity that fails to recognize the right to contract has claimed Marshall Revellyn Rinkenberger is a slave possessing no right to contract. Slavery, in all its forms, is a violation of Article 4 of the Universal Declaration of Human Rights, and

THAT, Marshall Revellyn Rinkenberger and all American Nationals have no affiliations nor memberships within the AMERICAN BAR ASSOCIATION (ABA), nor any of its State Bar association subsidiaries, and

THAT, despite these facts — established as part of the International Record — members of the ABA and its subsidiaries continue to pursue various forms of prosecution against Marshall Revellyn Rinkenberger and American Nationals. This is a violation of Article 3, 6, 7, 8, 15, 17 and 20 (2) of the UDHR. The failure of each BAR entity to adhere to their proper jurisdiction, that of regulating only the conduct of their members, reveals the violation of the intangible property rights to honest services.

ORDER

THEREFORE, THE GENERAL POST MASTER COUNCIL UNANIMOUSLY AGREES AND ORDERS THE FOLLOWING:

IT IS ORDERED, that the STATE OF MINNESOTA charge and action is hereby dismissed for lack of human rights within its proceedings and lack of recognition within its sphere, and

IT IS FURTHER ORDERED, that all accounts related to this matter are ordered closed and deleted pursuant to the Cancellatura of Foreign Instruments Act published by the Government of The United States of America, and

IT IS FURTHER ORDERED, that Marshall Revellyn Rinkenberger hereby removes his international person from the records of the STATE OF MINNESOTA to relieve the STATE OF MINNESOTA of any perceived or imagined liability, and

IT IS FURTHER ORDERED, that the property that is causing the dispute is hereby ordered recovered and shall reside within the office of the Treasury for the Government of The United States of America. The Treasury of the United States shall be notified that the property in question shall be classified as recovered property and shall reside in trust within the office of the Treasury for the Government of The United States of America, and

IT IS FURTHER ORDERED, that any form or attempt to profile as Sovereign Citizen, arrest, detain, or isolate a documented American National from their Government, intimidate, threaten any other type of arbitrary action including but not limited to passive aggressiveness and gang stalking against Marshall Revellyn Rinkenberger or any documented American National for whatever reason is an offense under multiple human rights violations. Any attempt to retaliate by claiming terrorism against Marshall Revellyn Rinkenberger or any American National or the Government of The United States of America by any American Bar Association member or any of its agencies will result in an immediate attempted murder charge against said perpetrators. Any non-recognition of this status is a contract violation and falls under the slavery clause of the Universal Declaration of Human Rights and the Convention on Civil and Political rights.

IT IS FURTHER ORDERED, that the definition of a foreign government as understood by this General Post Master Council and this United States is as follows:

The term foreign Government includes any government, faction or body of insurgents within a country with which the United States is at peace, irrespective of recognition by the United States Therefore, since the STATE OF MINNESOTA is a creature of the state, then its members would be classified as a body of insurgents and must decide whether or not it would like to remain at peace with this original United States and cooperate with the property recovery process, and
