JUDGMENT

BE IT JUDGED AND IT IS AGREED, AS THE GENERAL POST MASTER COUNCIL DOES HEREBY UNANIMOUSLY CONCUR WITH THE FOLLOWING:

THAT, it is the responsibility of the Government of The United States of America to protect the claims determined to be in honor brought forward by a claimant in defense of any and all violations of human rights, religious and political rights, cultural heritage, and the rights of the child; and

THAT, the General Post Master Council retains full jurisdiction over claimants that file claims within its court; and

THAT, a change of venue was filed with and accepted by this court of record, and Claimant abates any claim filed within the foreign court that may have caused any confusion as to jurisdiction of the General Post Master Council; and

THAT, there have been no objections to the international complaint filed with the Department of Defense made part of the international record on or about February 1, 2017; and

THAT, Claimant is a non-citizen, non-resident alien to the United States of America. Claimant retains full rights to the intangible property rights to the Claimant's children. This intangible property right has been violated and attempts at resolving the intangible property issue have been ignored by all named respondents.

THAT, evidence of slavery exists by the forced contract imposed by the United States of America Texas Office of the Attorney General Enforcement Division: Child Support Unit. Any and all other claims constitute denial of intangible property rights -including but not limited to child support, supervised visitation, restraining orders, probation, etc. against Claimant are hereby null and void;

THAT, the foreign court within the United States of America cannot force upon a foreign National any charge payable under its foreign sovereignty immunities act; and

THAT, any and all valid monetary claims against the Claimant will be paid using the Continental Dollar Legal Tender for debts public and private recognized by the Articles of Confederation as amended August 5th, 2015, and

ORDER

THEREFORE, THE GENERAL POST MASTER COUNCIL UNANIMOUSLY AGREES AND ORDERS THE FOLLOWING:

IT IS ORDERED, that the Claimant. hereby removes his international person from the records of the United States of America to relieve the United States of America of any perceived or imagined liability, and

IT IS ORDERED, that any declaration of jurisdiction for the administration of intangible property rights to the children listed in the Complaints and the rights of the child are hereby null and void and all accounts and records related to this matter are ordered closed pursuant to the Cancellatura of Foreign Instruments Act published by the Government of The United States of America. Further the accounts identified as case # 79359/case # 0012828761/case # (14-04-04047) within the United States of America be expunged with prejudice from its system.

IT IS ORDERED, that the Claimant will in no way be hindered in the Claimant's efforts to be reunited with Claimant's intangible property to Claimant's children, and further describe Claimant's intangible property as care and support the health and wellbeing of the children.

IT IS ORDERED, that the definition of a foreign government as understood by this General Post Master Council and this United States is as follows:

The term foreign Government includes any government, faction or body of insurgents within a country with which the United States is at peace, irrespective of recognition by the United States.
