Dear Sirs:

I write to you on behalf of Stuart Andrews Ronaldson, an affirmed American National and Trustee for The Burgess Trust, a trust registered within The United States of America. At issue is an on-going series of false claims made on the international record by third-party debt collectors.

On or about July 21, 2015, the General Post Master Council, a court within The United States of America, did issue the attached judgment and order to quiet title for property owned by The Burgess Trust (Link: <http://theunitedstatesofamerica1781.com/general-post-master-council-publications/>). The third-party collectors, not being a party of the trust registered within The United States of America, have no valid claim.

A courtesy notice of the quiet title judgment was sent to the county court and third-party collectors but rather than a simple acknowledgement of the foreign court judgment and respect for the order, the aggressors have elected to convert the international record and continue their false claims and harrassment.

When the promissory note was deposited into an account in the name of the original lender, AIGES WHOLESALE CORPORATION, the obligation of the buyer was declared by AIGES WHOLESALE CORPORATION to be discharged in full. Therefore, the property in question has been paid in full. Additionally, the record shows the entity AIGES WHOLESALE CORPORATION dissolved in 2008 voiding any contractual relationship between the buyer and the dissolved lender.

These un-recognized third parties continue to harass and file frauds before a court. The qualifications of the statutes claimed as authority for these filings are artificially manufactured to make it appear as if the statute is being fulfilled and the law is being followed.

I outline these points not to re-litigate the case— as the matter has been decided within the courts of The United States of America— but rather, to notice you that any further filings and harrassment by these parties will result in the Government of The United States of America pursuing all prosecution available to it as defined within Article 2(c) of the attached Declaration of Sovereignty
