**Mr. Chapin,**

**It appears you have placed yourself in a predicament that does not embrace the purpose of this Government.**

**This particular paragraph below is a violation of your oath or affirmation and the last affidavit was also a violation of your oath or affirmation.**

**The office of the Secretary of State for The United States of America is going to motion at tomorrows National assembly that Mark Chapin is deported back to the U.S. and will be allowed to return if in fact Mark Chapin completes an anger management course and receives other counseling as the professionals see fit.**

**You have failed to notice that the American Nationals that are a part of this Government do not trust you to be alone with their own children or wives.**

**Your actions in the past couple of weeks threatens to reverse everything that this Government stands for and has achieved in the past 6 years.
