AFFIDAVIT as amended

Day: 1st, Year of Yahweh: 6019 (03/20/2017)

Comes now, Juan Manuel Rueda, Jr. (hereinafter "Affiant"), being of lawful age, qualified and competent to testify and having firsthand knowledge of the following facts, does hereby declare that the facts stated herein are true, correct and not misleading to the best of Affiant's knowledge and belief:

The international complaint filed with the Department of Defense (hereinafter "DoD") on February 1, 2017 has been ignored.

After four (4) years of being involved with cause # 79359 in the (196th/354th) District Court the current condition is:

1. Claimant still has not obtained any remedy, resolution, nor Claimant's rightful custody/authority/place within the lives of Claimant's children;

2. Claimant demanded that the State of Texas withdraw from the private contract/covenant of Claimant's family, to no effect;

3. Due to human, children's, paternal, religious, political and cultural rights violations Claimant still demands remedy for said violations (*see Affidavit/Exhibits & DoD international complaint for listing of all rights violations [Link](#));

4. Claimant still has not obtained written confirmation that the 196th/354th Judicial District Court(s) has/have removed/expunged all inflammatory/demonizing label(s) (sovereign citizen, domestic terrorist, enemy of the State of Texas, etc.) placed on Claimant on/about September 30, 2014 (see Exhibit 1-2 & 8) from the Court record/law enforcement database(s)/sites. These labels rise to the level of attempted murder and are a violation of all (30) of Claimant's human rights;

5. The following record has not been removed from all databases/websites (Link: <http://mugshots.com/US-Counties/Texas/Hunt-County-TX/Juan-Manuel-Rueda.80771394.html>);

6. Stout's book/e-book and all related pages/websites constitute attempted murder of Claimant via demonizing/labeling Claimant a "sovereign citizen", etc. Claimant seeks immediate removal and for Stout to cease selling/promoting/sharing/giving away/etc. said book/e-book and all related pages/websites while label still exists. Stout has 3 days to correct said human rights violations and Claimant requires written confirmation from Stout (see Exhibit 2 & 8);

7. Claimant is an affirmed American National non-citizen, non-resident alien to the United States of America, and is foreign to the State of Texas. Claimant retains full rights to custody of Claimant's children/property. This right has been violated and attempts at resolving the custody issue have been ignored by Stout. Evidence of slavery exists by the forced contract imposed by the State of Texas/Texas Office of the Attorney General Enforcement Division: Child Support Unit, any and all other claims constitute denial of nationality -including but not limited to child support, supervised visitation, restraining orders, probation, etc. against Claimant are null and void;

8. Parental/paternal alienation, hostile aggressive parenting and malicious mother syndrome by Stout is in violation of the Convention of the Rights of the Child. Stout has not alleviated these violations in 4+ years and are still affecting Claimant's

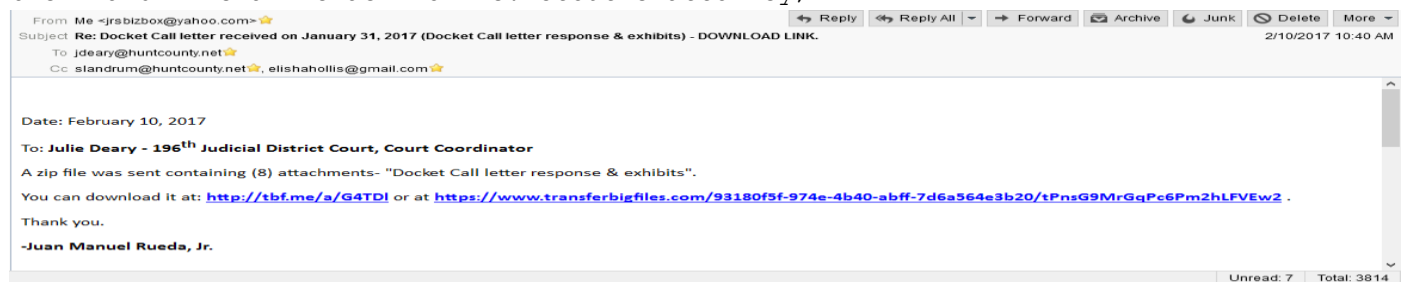

Isolation, manipulation, false victim role-playing, using "The Silver Bullet Technique" ([Link](#)), for physical/emotional/psychological torture, abuse, anguish, pain and damage caused by Stout and aided/sanctioned by all involved Respondents. Estrangement of children from their father (Claimant)/Claimant's family is in violation of the Convention of the Rights of the Child. Justifications of these violations are not withstanding and are still in the public record of Stout's book/e-book and all related pages/websites;

9. Stout, said District Court, the State of Texas, TX OAG, Vital Statistics and TX Dept. of State Health Services have not corrected/recorded/acknowledged Claimant's property's/daughter's name -according to Claimant's chain of title/Proof of Life and according to Claimant's daughter's amended Proof of Life (see Exhibit 34 B-C (B: The Social Compact Act of 10-07-2013- Father Will Have Authority Over Children ([Link](#)) C: (4) Proof of Life(s) ([Link](#));

10. Stout has on three different occasions taken/vanished/secreted Claimant's children/property without any notification with the intent of denying Claimant's access to children/without approval/consent/notification. Stout brought a weapon/knife to visitation on/about August 28, 2015 (see Exhibit 36);

11. Stout refuses communication and Claimant is unaware of the location/welfare of Claimant's children/property. All attempts by Claimant/Claimant's family to verify location/welfare of Claimant's children have been ignored;

12. The due process of notice was sent via email on/about February 10, 2017 to: Julie Deary: 196th District Court Coordinator; Stacie Landrum: 196th District Court Clerk and Elisha Michael Hollis: Stout's attorney;



13. Claimant verified that parties named in the above email were served notice and were given the chance to resolve the International Complaint. As of today's date no evidence exists that the controversy has been resolved and liability still exists for named Respondents; and

14. Claimant vacates any counter-claim that may have caused any confusion as to jurisdiction of Claimant.

Further, Affiant sayeth naught on this 1st day of the year of Yahweh, 6019.
