**MOTION FOR CHANGE OF VENUE TO

COMES NOW, Juan Manuel Rueda, Jr. (hereinafter "Claimant"), to motion this Court for a change of venue. In support of said motion, Claimant(s) state the following:

- 1) The Respondent(s) State of Texas (OAG Child Support Division) has no constitutional authority for holding court nor can it exist as a party to a case.
- 2) Claimant(s) is an American National and is entitled to a trial by jury of Claimant's peers. The foreign court cannot honor Claimant's right to a trial by jury of Claimant's peers as there are no American Nationals to hear the case at trial within the foreign court.
- 3) The Respondent's used/are using a foreign court (Hunt County District Court) to violate Claimant's human, children's, paternal, religious, political and cultural rights. Said foreign court forced/is forcing an American National to pay child support charges using Federal Reserve Notes - a private religious script not recognized by its U.S. Constitution nor any currency not recognized by The United States of America. Said violations are done using Title 42 US Code 666, and all actions taken to enforce it have been condemned by the reign of the heavens society Temple (see *Exhibit 33 & *34 A pg. 16). Enforcement is also done using the Social Security Act Title IV-D and the Texas Family Code, etc. The Government of The United States of America is not and American Nationals are not subject to harassing taxation demands, requests or threats of any kind from any foreign corporation, association, government, or other sovereign entity (see *Exhibit 51). Claimant knows it is not a crime to not pay child support and Claimant was brought to district court and to Claimant's understanding district court is criminal court.

4) The Claimant is an American National and therefore a non-citizen, non-resident alien to the United States of America, therefore charges/orders under the Social Security Act Title IV-D, the Texas Family Code § 105.006, 154.125, 154.129, 154.130, 154.182, 154.183, 154.185, 157.269, Title 4, Title 5 § 154, Texas Family Code Ch. 158, 231, and Title 42 US Code 666, etc. in case no. 79359 are moot. Therefore, all charges pertaining to Title 42 US Code 666, in cause no. 79359/case no. 0012828761 are to be dismissed.

5) Claimant motions for change of venue to the General Post Master Council for payment of assessed child support.
