### JUDGMENT

**BE IT JUDGED AND IT IS AGREED**, AS THE GENERAL POST MASTER COUNCIL DOES HEREBY UNANIMOUSLY CONCUR WITH THE FOLLOWING:

**THAT**, it is the responsibility of the Government of The United States of America to protect the claims determined to be in honor brought forward by a claimant in defense of any and all violations of human rights, religious and political rights, cultural heritage, and the rights of the child; and

**THAT**, the General Post Master Council retains full jurisdiction over claimants that file claims within its court; and

**THAT**, there have been no objections to the International Public Notice of Alien Tort Claim made part of the international record published on or about November 6, 2017; and

**THAT**, Claimant is a non-citizen, non-resident alien to the United States of America. Claimant has exhausted peaceful settlement of dispute with all issues having been ignored by all named respondents which have resulted in default judgement; and

**THAT**, evidence of Human Rights Violations against all thirty articles of the Universal Declaration of Human Rights have occurred by Grand Master Dieter B. Hees of The GRAND LODGE OF NEW JERSEY, Patrolman Rodgers, Officers id no. 1632 aka STATE OF NEW JERSEY, TOWNSHIP OF HARRISON POLICE DEPARTMENT et al, TOWNSHIP OF HARRISON\_COURT, Judge Thomas M. North and Prosecutor Gary Lomanno, et al.
