The General Post Master Council has jurisdiction in the nature of an Article III court, much like a federal district court granted to Interstate commerce by the states. Interstate commerce is universal with all sovereign entities subject to the Law of Nations and International Law. Interstate commerce is not exclusive to the United States. This case requires an Interstate commerce venue rather than an intra-state commerce venue because there are multiple statuses involved.

The government of the state of Texas does not have the proper interstate-commerce venue or jurisdiction to hear a case of this nature as the person involved with this conflict has not politically demeaned his person to a mere faithful citizen or subject of the government of the state of Texas.

**COMES NOW**, The Government of The United States of America (hereinafter "Claimant"), to motion this Court to issue a Judgement and Order to Nationalize the City of Conroe for Human Rights Violations for stolen property unlawfully seized to wit:

**IT IS ORDERED**, Motion to Nationalize the City of Conroe within the state of Texas for human rights violations against the respondents and tort feorsors for refusing to return the stolen property (motor Vehicle) is granted.
