INTERNATIONAL PUBLIC NOTICE, AS AMENDED ON 02-02-2017

The General Post Master Council is a court of law and equity serving the jurisdiction and venue of the Government of The United States of America. The Government of The United States of America is a subject of the Law of Nations, and

All documented American Nationals, Declared Residents, and General Post Masters are, by voluntary contract, subject to the General Post Master Council. Any non-recognition of this voluntary contract is a violation of the right to contract. Any person or entity that fails to recognize the right to contract has claimed the documented American National is a slave possessing no right to contract. Slavery, in all its forms, is a violation of Article 4 of the Universal Declaration of Human Rights, and

Article 4: No one shall be held in slavery or servitude; slavery and the slave trade shall be prohibited in all their forms.

IT IS HEREBY NOTICED that the “Zero Tolerance” policy regarding human rights violations and aggressive actions against documented American Nationals, Declared Residents, and General Post Masters by foreign jurisdictions, as published and made part of the International Record on the 24th day of May, 2016, by the General Post Master Council, shall be amended. (Publication link: <http://americanherald.org/?p=840>)

IT IS HEREBY NOTICED that any non-recognition of credentials issued by the Government of The United States of America to a documented American National, Declared Resident, or General Post Master or any confiscation of such credentials or any form of detention reveals systemic, habitual, and intentional techniques of demoralization and is an international copyright violation, theft, human trafficking, slavery, denial of nationality, and forced association. Despite these facts established as part of the International Record members of the ABA and its subsidiaries continue to pursue various forms of prosecution against American Nationals, Declared Residents, and General Post Masters. This is a violation of Article 3, 4, 6, 7, 8, 9, 15, 17 and 20 (2) of the UDHR. The failure of any perpetrating entity to adhere to their proper jurisdiction, that of regulating only the conduct of their members,

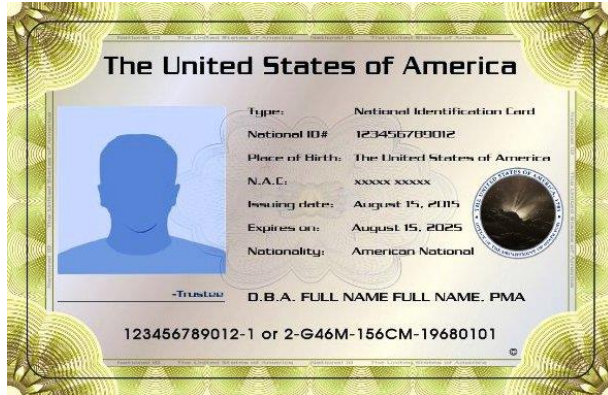

IT IS HEREBY NOTICED that any attempt to publicly slander or otherwise demonize a documented American National, Declared Resident, or General Post Master with the use of inflammatory labels including but not limited to “sovereign citizen”, “anti-government” “anarchist”, “radical” and the like, will result in an immediate charge of attempted murder brought against the perpetrator(s) by the Government of The United States of America wherein their person shall be placed in EXILE within three days by Executive Order, and

IT IS HEREBY NOTICED that any attempt to confine or otherwise isolate a documented American National, Declared Resident, or General Post Master from his or her Government, or any attempt to intimidate, threaten or coerce statements or behaviors from a documented American National, Declared Resident, or General Post Master will result in immediate filing of human rights violations against the perpetrator(s) by the Government of The United States of America by report wherein the perpetrators person shall be placed in EXILE within three days by Executive Order, and

IT IS HEREBY NOTICED that The Government of The United States of America nor the documented American National, Declared Resident, or General Post Master is not responsible for any bill issued by any private detention center when detaining a documented American National, Declared Resident, or General Post Master. The documented American National, Declared Resident, or General Post Master is not responsible for any fines for offending a foreign jurisdiction in whatever form and nothing can be used against the documented American National, Declared Resident, or General Post Master in whatever form, and



IT IS HEREBY NOTICED that during three (3) business days from the date of any international incident involving a documented American National, Declared Resident, or General Post Master, including but not limited to weekends and holydays, evidence of injury or damage to property incurred as the result of behaviors of an American National, Declared Resident, or General Post Master, may be submitted to the Clerk for the Court serving the General Post Master Council.

NOTATIONS

Notes of recognized and accepted authorities within the U.S. states of the foregoing notice:

"United States is foreign as to the States of the Union" "The defendants have correctly stated the well established principle of law that the Government of the United States is foreign as to the States of the Union within the rule of private international law that the penal statutes of one sovereignty will not be enforced by another. Robinson v. Norato, 71 R.I. 256, 43 A.2d 467, 162 A.L.R. 362; State of Wisconsin v. Pelican Ins. Co., 127 U.S. 265, 8 S. Ct. 1370, 32 L. Ed. 239. It is universally recognized that foreign jurisdictions will not enforce penal statutes of another state. Galveston, H. & S. A. R. Co. v. Wallace, 223 U.S. 481, 32 S. Ct. 205, 56 L. Ed. 516; The Antelope, 10 Wheat 66, 23 U.S. 66, 6 L. Ed. 268, wherein Chief Justice Marshall made the short statement that, "The Courts of no country execute the penal laws of another." (Salonen v. Farley, 82 F. Supp. 25 (E.D. Ky. 1949))

The laws of one State/Nation are not applicable to other States/Nations

"It is equally well settled that the several states of the Union are to be considered as in this respect foreign to each other, and that the courts of one state are not presumed to know, and therefore not bound to take judicial notice of, the laws of another state." (Hanley v. Donoghue, 116 U.S. 1, 29 L. Ed. 535, 6 S.Ct. 242, 244 (1885))

"By the law of England and of the United States, the penal laws of a country do not reach beyond its own territory except when extended by express treaty or statute to offenses committed abroad by its own citizens, and they must be administered in its own courts only, and cannot be enforced by the courts of another country." (Wisconsin v. Pelican Ins. Co., 127 U.S. 265 (1888))



The political existence of a State is independent of other States.

“The political existence of the State is independent of recognition by other States. Even before being recognized, the State has the right to defend its integrity and independence, to provide for its preservation and prosperity, and consequently to organize itself as it sees fit, to legislate concerning its interests, to administer its services, and to determine the jurisdiction and competence of its courts. The exercise of these rights is limited only by the exercise of the rights of other States in accordance with international law.” (Article 13, Charter of the Organization of American States).
