## INTERNATIONAL PUBLIC NOTICE

The General Post Master Council is a court of law and equity serving the jurisdiction and venue of the Government of The United States of America. The Government of The United States of America is a subject of the Law of Nations.

All documented American Nationals are, by voluntary contract, subject to the General Post Master Council. Any non-recognition of this voluntary contract is a violation of the right to contract. Any person or entity that fails to recognize the right to contract has claimed the documented American National is a slave possessing no right to contract. Slavery, in all its forms, is a violation of Article 4 of the Universal Declaration of Human Rights.

*Article 4: No one shall be held in slavery or servitude; slavery and the slave trade shall be prohibited in all their forms.<sup>1</sup>*

You are hereby noticed, as published and made part of the International Record on the 24<sup>th</sup> day of May, 2016, that the General Post Master Council has adopted a “Zero Tolerance” policy regarding human rights violations and aggressive actions against documented American Nationals by foreign jurisdictions. You are hereby noticed that any non-recognition of credentials issued by the Government of The United States of America to a documented American National, or any confiscation of such credentials is an international copyright violation and the violator(s) will be prosecuted in the name of the Government of The United States of America for the return of the property and possible levy of international sanction or fine against the perpetrator(s) of the crime.

You are hereby noticed that any failure to recognize the National currency issued by the Government of The United States of America is a violation of Article 15 of the UDHR and the violator(s) will be prosecuted in the name of the Government of The United States of America for violation of Article 15 of the UDHR.

You are hereby noticed that any attempt to publicly slander or otherwise demonize a documented American National with the use of inflammatory labels including but not limited to “sovereign

citizen”, “anti-government” “anarchist”, “radical” and the like, will result in an immediate charge of attempted murder brought against the perpetrator(s) by the Government of The United States of America.

You are hereby noticed that any attempt to confine or otherwise isolate a documented American National from his or her Government, or any attempt to intimidate, threaten or coerce statements or behaviors from a documented American National will result in immediate filing of human rights violations against the perpetrator(s) by the Government of The United States of America.

You are hereby noticed that any jurisdiction that attempts to place a documented American National on trial will result in an immediate International Complaint filed with the proper authority against the entity number of said jurisdiction. If such authority fails to resolve the matter, that entity number falls under the jurisdiction of the Human Rights Tribunal and is subject to any and all international sanctions imposed by that Tribunal, enforceable by customary international law.

You are hereby noticed that you have three (3) business days from the date of any international incident involving a documented American National to provide to this court irrefutable evidence that you have expunged the record against the documented American National and cured all human rights violations related to the matter or the records are transferred to the Clerk for the Court serving the General Post Master Council. The Government of The United States of America and the documented American National is not responsible for any bill issued by any private detention center when detaining a documented American National. The documented American National is not responsible for any fines for offending a foreign jurisdiction in whatever form and nothing can be used against the documented American National in whatever form.
